

#### **ACADEMIC SENATE IN-BRIEF**

An update on the key decisions made and matters discussed by Academic Senate on 26 July 2022.

#### **Overview**

#### **Matters resolved**

Academic Senate passed 22 resolutions at this meeting. Information on outcomes of specific agenda items may be found in this report or within the minutes.

#### **COURSES: NEW AND AMENDMENTS**

Academic Senate approved the introduction of the Undergraduate Certificate of Commerce, the Undergraduate Certificate of Software Engineering, the Diploma of Software Engineering and the Diploma of Game Design and Development to be offered by the Macquarie University College with effect from 1 January 2023. It also approved amendments to the Master of International Trade and Commerce Law, the Master of Laws, the Bachelor of Arts (OUA) and the Master of Information Technology in Networking (Res AS22/56).

#### POLICIES AND PROCEDURES

# Academic Progression Policy and Procedure (Res AS22/55)

Academic Senate approved the revised <u>Academic Progression Policy and Procedure</u> with immediate effect, and consequential amendments to the Academic Appeals Policy and Procedure to align nomenclature.

# **Review of HDR and MRes Termination of Candidature Procedure** (Res AS22/59)

Academic Senate approved the new <u>Graduate Research Continuation Policy</u>, the amended HDR and MRes Termination of Candidature Procedure (including a new supporting flowchart) and a change of name for the Procedure to become the Graduate Research Continuation Procedure, with immediate effect.

# **Assessment Procedure: Request for Partial Exemption for EDST2100** (Res AS22/58)

Academic Senate approved a <u>partial exception</u> to the requirement of Clause 117 of the Assessment Procedure to publish final examinations in the University Library for EDST2100 Language and Literacies, subject to the Faculty providing sample practice quizzes in iLearn and the retention of any examination papers already published with the Library. It was noted that the practice of providing exemptions from this requirement will be reviewed as part of the upcoming post-implementation review of the Assessment Policy and Procedure.

# **OTHER MATTERS**

- The Chancellor attended the meeting as an observer and spoke briefly on the relationship between Council and Academic Senate;
- The Vice-Chancellor spoke to members on matters including positive indications from the Federal Government (noting specific details have yet to be released), ongoing engagement with the NSW State Government, appointments to and recruitment for senior positions (including the new Deputy Vice-Chancellor (Academic), Professor Rorden Wilkinson), and student load for the remainder of 2022;
- The Interim Deputy Vice-Chancellor (Academic) provided a report on matters in her portfolio, including the Education Strategy Committee, the introduction in S2 2022 of a standard 5% penalty for late assessments, and an update on TEQSA re-registration and the response to the ESOS audit;
- Academic Senate noted the report of the MQ Way for Education and Employability, a thematic review commissioned by the Vice-Chancellor, including the establishment of the MQ Way Steering Committee to develop the Thematic Review Success Plan for implementation of the report recommendations (Res AS22/70);
- Academic Senate ratified seven cotutelle agreements entered into since the previous meeting of Academic Senate (Res AS22/60);
- Academic Senate endorsed a recommendation for the award of the title of Professor Emeritus for recommendation to Council (Res AS22/61);
- Academic Senate endorsed the Academic Year Plan for 2024 for recommendation to the Deputy Vice-Chancellor (Academic) for approval (Res AS22/62);
- Academic Senate ratified decisions made under executive action by the Chair of Academic Senate related to the award of the Macquarie University Award for Academic Excellence to coursework graduands and the Macquarie University College Award for Academic Excellence to Macquarie University College graduands (Res AS22/72); and
- Academic Senate ratified savings cases approved under executive action by the Chair of Academic Senate (Res AS22/73).
