

ACADEMIC SENATE IN BRIEF

An update on the key decisions made and matters discussed by Academic Senate on 5 August 2025.

DECISIONS OF THE MEETING

Academic Senate passed 24 resolutions at this meeting. Information on outcomes of specific agenda items may be found in this report or within the minutes.

Curriculum: Amendments and Discontinuations

Course Accreditations: Nanjing Macquarie Joint Institute (Res AS25/65)

Academic Senate approved the accreditation of three courses to be offered via the Nanjing Macquarie Joint Institute (NMJI): Bachelor of Science (NMJI), Bachelor of Information Technology (NMJI) and Bachelor of Environment (NMJI).

Curriculum Proposals (Res AS25/60)

Academic Senate approved proposals from the Faculty of Arts to accredit the Bachelor of Criminology (OUA), Bachelor of History, Bachelor of History (OUA), Bachelor of International Studies, Master of Education, Master of Criminology, Master of Criminology (OUA), Master of Intelligence, Master of Intelligence (OUA), Master of Strategy and Security, Master of Strategy and Security (OUA), Graduate Certificate of Strategic Policy (OUA) from January 2026. Senate also approved a proposal from the Faculty of Science and Engineering to accredit the Master of Engineering (Professional) from January 2026.

Academic Senate also approved proposals from the Faculty of Science and Engineering to discontinue the Master of Information Technology in Internet of Things and the Master of Information Technology in Networking from January 2026, and approved proposals from the Faculty of Arts, Macquarie Business School, Faculty of Medicine, Health and Human Sciences and Faculty of Science and Engineering to amend the Master of Teaching (Birth to Five), Bachelor of Commerce, Bachelor of Psychology, Bachelor of Clinical Science, Master of Speech and Language Pathology, Master of Clinical Psychology, Master of Clinical Audiology, Bachelor of Speech and Hearing Sciences, Master of Conference Interpreting, Master of Translation and Interpreting Studies (Advanced), Bachelor of Psychology (OUA) and Bachelor of Science from January 2026.

Course Reaccreditation Proposals (Res AS25/61)

Academic Senate received the final course review reports for the Accounting course bundle from the Macquarie Business School and approved the Faculty's recommendation that the Bachelor of Professional Accounting, Master of Accounting and Master of Professional Accounting be reaccredited for a period of seven years without conditions. Senate also received three final course review reports from the Faculty of Science and Engineering and approved the Faculty's recommendation that the Master of Information Systems Management, Master of Information Technology in Cyber Security, Graduate Diploma of Information Technology (exit award), Graduate Certificate of Information Technology, Master of Biotechnology, Graduate Diploma of Biotechnology and Bachelor of Engineering (Honours) be reaccredited for a period of seven years without conditions. Senate also noted the Faculty of Science and Engineering's advice that the Master of Information Technology in Networking will be discontinued and is not recommended for reaccreditation.

Academic Senate approved the proposed changes to Schedule 2 Additional Entry Requirements to Research Training Courses of the Graduate Research Admissions Policy for effect upon publication.

Amendment to English Language Requirements (Res AS25/63)

Academic Senate approved the proposed changes to English proficiency tests and the editorial amendments to the Admissions Policy Schedule 1 English Language Admission Requirements to Coursework and Non-award Courses, to take effect from 1 September 2025.
