1. Research Program

2021 was a highly productive year for CMH research. Four books were published by CMH members and associate members: Toby Davidson's *Good for the Soul: John Curtin's Life with Poetry* (UWA Press); Craig Munro's *Literary Lion Tamers: Book Editors who Made Publishing History* (Scribe); John Potts (ed.) *Use and Reuse of the Digital Archive* (Palgrave Macmillan) and Hsu-Ming Teo (ed. with J. Kamblé and E. M. Selinger) *The Routledge Research Companion to Popular Romance Fiction* (Routledge). Twenty book chapters and thirty journal articles were published in 2021 by CMH members and associate members.

Members Dr Alec Morgan and Dr Tom Murray received major recognition for their documentary films *Ablaze* (Morgan) and *The Skin of Others* (Murray) through the award of high-profile industry prizes. Dr Morgan was awarded the Victorian Premier's History Award, two ATOM (Australian Teachers of Media) awards, for Best Documentary – Indigenous Video or Website and Best Documentary – Social and Political Issues, and an AWGIE (Australian Writers Guild) award for *Ablaze*. Dr Murray was awarded the ATOM Award for Best Documentary – Doco-drama for *The Skin of Others*. In addition, both films were nominated in several other ATOM and AWGIE categories.

The ARC Discovery Grant project, 'Cultural Conversations: A History of ABC Radio National', involving CMH members Dr Virginia Madsen, Professor Bridget Griffen-Foley and Professor John Potts, concluded in 2021. This project generated 15 peer reviewed articles and book chapters overall, a book in progress (delayed due to COVID) and a large oral history collection to be made available to the National Library, National Film and Sound Archives and ABC or National Archives. Professor John Potts' ARC Linkage Grant 'Digitising the Kaldor Public Art Projects Archive' also concluded in 2021. This project created a digital archive, linked as an online resource to the CMH website, and a book of essays, *Use and Reuse of the Digital Archive*. Dr Tom Murray continued his ARC Future Fellowship in 2021. Member Professor Michelle Arrow received an ARC Special Research Initiative for Australian Society, History and Culture in 2021. She was awarded \$176,638 to assist her in writing a biography of the late Australian journalist, Anne Deveson AO. Member Associate Professor Tanya Evans is part of a team awarded an ARC Linkage Grant for the project 'History, Heritage and Environmental Change in a Deindustrialised Landscape'. Associate member Mei-fen Kuo was awarded an Asia Study Grant for her project 'Documenting Chinese Australian Community in the Context of Cold War'.

COVID-19 restrictions in 2021 forced the cancellation of several scheduled CMH public events. This included the 2021 Brian Johns Lecture. However, the Copyright Agency has deferred funding of the public lecture to 2022, and the event is scheduled for June 2022 at the State Library. The exhibition 'Comics and Activism', curated by CMH members Dr Justine Lloyd and Dr Can Yalcinkaya, was held at Macquarie University Art Gallery from 1 July-20 August. Requests to tour this exhibition in 2022 have been received by Perth Comic Arts Festival and Santospirito, Hobart. Other CMH events proceeded as Zoom virtual events in 2021. These were: the 'Harbour Cities: media in urban and regional histories' panel at the Australian Media Traditions conference, 29 September, involving Dr Justine Lloyd, Dr Chris Müller & Dr Virginia Madsen (CMH) and Dr Hans-Ulrich Wagner (University of Hamburg Research Centre for Media History); *Lines of Resistance: A Virtual Symposium on Media, Arts and Activism*, held on 2 November, convened by Dr Can Yalcinkaya and Dr Justine Lloyd; *Real is Not Real Enough*, an audio experience based on Günther Anders' 1941 Californian exile diary, by member Dr Chris Müller, Benjamin Nickl and Helen Wolfenden, launched at Goethe Institute Sydney on 9 December.

Professor John Potts commenced as CMH Director in September, following a period earlier in the year in which Dr Justine Lloyd served as Acting Director. Professor Potts appointed Kate Manlik as Administrative Officer of the CMH in September. The goals of the new Director are to enhance the Centre's profile, and to boost the Centre's research output. To this end, a major renovation of the CMH website was undertaken in late 2021. A new section, 'Publications', was added, showcasing all publications and media productions by members and associate members over the last six years. An 'About' section was also added, including a brief history of the Centre, and a description of the types of research conducted in the Centre, following an expanded conception of media history. A number of new online resources were added to the 'Resources' section: Words in Place: a digital cartography of Australian writers in Sydney, Melbourne and Canberra produced by associate member Dr Toby Davidson and Dr Donna Houston; Kaldor Public Art Projects Digital Archive, produced as part of the ARC Linkage Grant project 'Digitising the Kaldor Public Art Projects Archive', led by CMH Director Professor John Potts; and Real is Not Real Enough, an audio work produced by a team including member Chris Müller. The 'News & Events' section of the website was re-activated. In addition, the Director inaugurated a monthly CMH email newsletter, announcing CMH events, news and achievements. The first two newsletters were distributed in November and December. Non-members can subscribe to the newsletter on the CMH website.

Finally, a campaign to re-invigorate members' involvement with the Centre was initiated. All members and associate members were asked to update their profiles on the 'People' section of the CMH website. The Director recruited new associate members to the CMH, bringing into the Centre a diverse range of approaches to media history. The six new associate members appointed in late 2021 are: Associate Professor Stephanie Russo, Dr Daozhi Xu, Dr Mei-fen Kuo, Dr Toby Davidson, Dr Pat O'Grady and Kate Manlik. This expanded membership promises to generate increased research output from the Centre.

The Advisory Board and executive of the Centre feel that it is important for HDR candidates at Macquarie University working in media history to be given recognition as associate members of the CMH, and to feel that they are part of a vibrant community of scholars working across multiple disciplines.

There are three HDR students who are associate members of the CMH: Michael Dwyer, Kate Manlik and Fereydoun Pelarek.

In addition, Queenie Chan, a PhD Candidate at Macquarie University, presented a paper entitled 'Using Hybridised Digital Comics to Address Issues of Social Justice', at the *Lines of Resistance* Symposium hosted by the CMH in November 2021.

PhD candidate Kate Manlik was appointed Administrative Officer of the CMH in September 2021 and has provided valuable assistance in CMH activities, particularly in the re-structuring of the CMH website, and the compilation of the publications list and monthly newsletters.

7. Other comments on the effectiveness of the centre on promoting collaborative research in the nominated research area

The CMH conducts media history research according to a broad, inter-disciplinary definition of media history. The research focus includes not only the history of mass media, but also research into online media, digital media, media arts, electronic arts, literary history, publishing history, and art history. This expanded definition also acknowledges researchers who incorporate elements of media history in works of cultural history, intellectual history, history informed by feminism or queer theory, post-colonialism and critical race theory, and digital humanities. Accordingly, research conducted by the Centre is frequently collaborative and inter-disciplinary. The CMH-hosted conference planned for 2022, 'New Directions in Media History' encourages inter-disciplinary research, while collaborative papers are also encouraged; papers from this conference will be published in an edited collection of essays on media history.

The CMH plans to collaborate with other media centres and institutions – including the National Film and Sound Archive and ABC – in staging research events such as symposia and conferences in 2022. Finally, the CMH will engage in close collaboration with international research centres including the University of Hamburg Research Centre for Media History, and develop new international partnerships. Such collaboration with international partners also creates the possibility of applying for EU and other international funding for collaborative projects.
