The following information is provided as general guidance to applicants to Master of Clinical Psychology, Master of Clinical Neuropsychology, Master of Organisational Psychology and Master of Professional Psychology at Macquarie University. Information included in this guide will ensure applications can be completed with all information required for assessment. HOW MACQUARIE UNIVERSITY WILL CONTACT YOU

Email will be the primary means of contact between Macquarie University and applicants.

It is essential that you provide a current email address which will be valid through to March 2026 and that you regularly check your emails.

You are advised to provide an email address other than your current university address unless it will be available until March 2026.

Some email messages may be blocked or flagged as spam by some email providers. To avoid missing important information please check your junk mail folder, especially if you use a web-based email client such as Gmail or Hotmail.

Macquarie University will not be held responsible for undeliverable or unread email communication.

It is recommended to use the same email address for all components of the applications process.

ADMISSION POLICIES

Offers

Successful applicants will be given a firm date by which to accept an offer of a place. Offers not accepted by that date will lapse.

IF AN APPLICANT DECLINES AN OFFER, OR ALLOWS THE OFFER TO LAPSE, THEY WILL NOT BE CONSIDERED FURTHER FOR THAT COURSE IN THE 2026 INTAKE. It is still possible to receive an offer for other MQ courses that were preferred in the application.

Deferral

Deferral of a place is not available, and applicants must reapply if they wish to be considered for the following year.

Exclusion

An applicant who has been excluded from any university must indicate this when they apply. Applicants whom this applies to may be contacted for further details.

Admission and application irregularities

It is important that you present accurate records for assessment. Applicants should be aware that the presentation of forged documents is a criminal offence in Australia and that universities may take appropriate action in such cases. All tertiary study must be declared in the application. For the purpose of university admission, the withholding of information and the submission of incorrect or misleading information are deemed fraudulent. Action taken in such cases may include cancellation of an application for admission, withdrawal of an offer of admission, or cancellation of an enrolment. Applicants who submit fraudulent documents or otherwise seek to gain an advantage by fraudulent means may be banned from future applications to Macquarie University.

As soon as you have accepted an offer or place at another university, then please be considerate of fellow applicants and withdraw your Macquarie application/s as soon as possible.

APPLICATION PROCESS

Macquarie University makes every effort to ensure the accuracy of information provided in this admission guide at the time of publication. Applicants are responsible for determining their eligibility to apply and should review admissions requirements in this guide and the [Macquarie University Coursefinder](#) for the course you are applying for. The application process is competitive, and the university receives a large number of applications for each course. The application process is broken up into stages, each of which is competitive and only those deemed competitive will progress to the next stage.

STAGE 1 – APPLICATION SUBMISSION

Applicants must complete all components of the application submission process by the closing date to be considered for stage 2. Incomplete applications will not be assessed.

Invitations for the interviews and offers for admission to the course are highly competitive. Meeting the minimum stated requirements does not guarantee progression to the next stage of the application process.

All components must be submitted **by 31 October 2025** with assessments for Stage 1 shortlisting occurring shortly after. Applications that do not meet the minimum of 1 or more components will not be considered further and will receive a notification that they do not qualify.

Shortlisting for invitation to participate in Stage 2 and the Interviews is highly competitive and as such meeting the minimum stated requirements of Stage 1 does not guarantee an invitation to attend an interview. Shortlisting is based on all components listed above in Stage 1 including information provided to the Universities Admission Centre (UAC), referee reports, and completion of the Macquarie University Supplementary Form.

Offers for interview will be sent out in **mid-November 2025**.

STAGE 2 –INTERVIEWS

The interview is designed to assess qualities considered by Macquarie University to be associated with success in both the study of psychology and later practice. Interviews will be held in person at the Wallumattagal Campus, North Ryde and either a panel or Multiple Mini Interview as shown in the table below.

Shortlisted applicants will be sent an invitation via email to attend an interview to be held in mid-late November.

Applicants are selected for interview based on all components listed below in table 5 and includes all information provided to the Universities Admission Centre (UAC) (domestic applicants), Macquarie University (international applicants), referee reports, and completion of the Macquarie University Supplementary Form.

Applicants successful in progressing to the interview stage will receive a letter inviting them to the interview. The letter will include details about the format of the interviews and next steps.

Academic and ranking performance will not be discussed at the interview.

Applicants must meet all expenses associated with attending the interview.

Applicants unsuccessful in receiving an interview will be notified via UAC or email by Macquarie University. Applicants who were not interviewed will not participate in further processing.

STAGE 3 – OFFERS

Following the final ranking, applicants are checked to ensure they have completed a level 2 course in psychology with a result above the minimum required to qualify for the course. Refer to the relevant [entry requirements](#) to check this.

Offers will be sent via UAC for domestic students and email for international students and will have a date by which they must accept the offer. If no action has been taken by the due date, the offer will 'lapse' and the next highest ranked applicant will receive an offer.

Applicants who have not submitted their final Level 2 psychology course results will receive conditional offers only and will not be able to be admitted into the course until this condition is lifted. Applicants on a conditional offer should not apply for provisional registration due to the time limits in the registration process. The university will not be able to confirm your enrolment until you have had the condition lifted and enrolled into the course.

Applicants who participated in an interview but were unsuccessful in receiving an offer in the early stages will either receive a notification via UAC or email that they are still in consideration pending confirmed numbers or they were unsuccessful

QUOTAS

There are limited places available in each of the courses. There are a limited number of Commonwealth Supported Places (CSP) and the remaining places being either domestic full fee paying or international fee paying.

FITNESS TO PRACTICE AND INHERENT REQUIREMENTS

Before accepting their offer, applicants are reminded to review the Fitness to Practice and Inherent requirements for the course they are accepting.
