## **Chancellor's Report**

The Chancellor provided a report on the reframing of the Council Strategy Session, in consideration of, among other things, the impact of the COVID-19 pandemic on the day-to-day operations of the University and achievement of current strategic objectives.

## Vice-Chancellor's Strategy and Enterprise Performance Report

The Vice-Chancellor provided a report on the University's strategy and enterprise performance, including updates on contingency planning in moving back to an online study and work environment and implementation of additional safeguards across the University's IT network.
