Matters resolved

Academic Senate passed 20 resolutions at this meeting. Information on outcomes of specific agenda items may be found in this report or within the minutes.

COURSES: NEW AND AMENDMENTS

Academic Senate approved amendments to the Bachelor of Laws, the Bachelor of Philosophy/Master of Research (Science and Engineering), the Master of Research (Science and Engineering) and the Master of Business Administration (Res AS22/98).

POLICIES AND PROCEDURES

Course of Study Reaccreditation Policy (Res AS22/96)

Academic Senate approved revisions to the Course of Study Reaccreditation Policy with immediate effect.

Unit of Study Review Policy (Res AS22/97)

Academic Senate approved amendments to the Unit of Study Review Policy with immediate effect.

Amendment to the Higher Doctoral Degree Rules and Academic Costume Rules

(Res AS22/100)

Academic Senate endorsed and recommended to University Council amendments to the Higher Doctoral Degree Rules and Academic Costume Rules with immediate effect. The amendments relate to the renaming of the Doctor of Medicine Higher Doctoral Degree (AQF 10) as the Doctor of Medical Science.

Review of Peer Assisted Learning and Peer Assisted Study Session Policy, Procedure and Schedule (Res AS22/106)

Academic Senate approved the revised Peer Assisted Study Session Procedure with effect from 1 January 2023, and the expiration of the Peer Assisted Learning and Peer Assisted Study Session Policy from the date of publication of the revised Procedure.

Work Integrated Learning Policy (Res AS22/107)

Academic Senate noted an update on the development of the Work Integrated Learning Policy.

Third Party Arrangements Policy and New Educational Products Policy (Res AS22/110 and AS22/111)

Academic Senate noted a report on the development of the Third Party Arrangements Policy, noting the final version will be approved by the Vice-Chancellor. Senate also noted a report on the recent approval of the New Educational Products Policy by the Vice Chancellor.

Academic Senate noted a list of policies under review/development as of 4 October 2022.

GOVERNANCE AND STRATEGY

Academic Senate Oversight of Academic Risks (Res AS22/104)

Academic Senate received and endorsed Quality and Standards Review reports on the two areas under Standard 4 (Research and Research Training) and three of the four areas under Standard 5 (Institutional Quality Assurance) of the Higher Education Standards Framework.

Student Performance Report (Indigenous Students) (Res AS22/105)

Academic Senate received and noted reports from the Student Outcomes Group including the Annual Student Cohort Report (Indigenous Students), Report of Progress on Recommendations following the Annual Student Cohort Report (Indigenous Students), 2021 Student Experience survey Summary Benchmarking Report from BIR and the Student Outcomes Group Reporting Framework.

2023 Academic Senate Annual Agenda Plan and Projects: Planning (Res AS22/102) Academic Senate discussed the process for planning for projects in 2023 and the 2023 Annual Agenda Plan, noting a survey had been sent to members seeking their input.
