

ACADEMIC SENATE IN BRIEF

An update on the key decisions made and matters discussed by Academic Senate on 27 August 2024.

DECISIONS OF THE MEETING

Academic Senate passed 16 resolutions at this meeting. Information on outcomes of specific agenda items may be found in this report or within the minutes.

Curriculum: Amendments and Discontinuations

Course Reaccreditation Proposals (Res AS24/68)

Academic Senate reaccredited the Bachelor of Planning, the Master of Planning and the Graduate Certificate of Environmental Planning from the Faculty of Arts for a period of seven years without conditions.

Curriculum Proposals (Res AS24/69)

Academic Senate approved the discontinuation of nine Diplomas of Languages from the Faculty of Arts and accredited a new Master of Laws in Corporation, Human Rights and Sustainability and Graduate Certificate in Financial Integrity Law, also from the Faculty of Arts. Academic Senate also acted as Faculty Board in approving amendments to MRES7001 PACE: For Research, a unit offered through the Graduate Research Academy.

Policies and Procedures

Revised Course of Study Suspension and Discontinuation Policy (Res AS24/67)

Academic Senate approved amendments with effect from the date of publication to the Course of Study Suspension and Discontinuation Policy noting it will also be renamed to the Course of Study Discontinuation Policy.

- Academic Senate noted advice on upcoming elections for academic staff and student member positions on Academic Senate (Res AS24/79).
