CREATE AND SUBMIT AN NHMRC Investigator Grant 2022



OVERVIEW

This guide explains how to create and submit an NHMRC Investigator Grant application as a Researcher within the Pure Research Management System (Pure RMS). This is additional information to the basic '[CREATE AND SUBMIT AN APPLICATION IN PURE RMS](#)' QRG.

PROCESS



STEPS

1. Log into [Pure RMS](#) with your OneID and password.
2. Create your NHMRC IG from the Proposal template.
(click Application, click Application, click Grant then click Proposal)
3. In the identification section -
 - Provide a title.
 - Copy and paste your proposal summary to the description box.
 - Click Add ID to add your external NHMRC Application number (select External Reference Number from the dropdown).
4. Your details are automatically populated for the next sections.
5. At the Funding Opportunity stage please select '95238747 – NHMRC - Investigator Grants' or type in '95238747' which will bring up the correct opportunity. Do not select INACTIVE_DNU funding opportunities.

- At the Funding Organisation stage please type in 'National Health and Medical Research Council' and make sure it says Research Services Verified in small grey writing or type in '14912140'.



- At the 'Funding project scheme (research programme)' line copy and paste the following:
-95238747 – NHMRC - Investigator Grants

- In the financial summary section put the total amount asking from the NHMRC IG, in the box with the red asterisk. You must enter an amount, or you cannot save or exit from this screen.

- Click on the Add budget section. Organisation will appear, type in your department.

- If the contribution is in kind, click on the radio button and type in the estimated value in the space provided.

- Enter the life cycle of the project – '1/1/2023-31/12/2027'
- Add your documents.
- Enter your Fields of Research.
- Make sure to enter all MANDATORY FIELDS. This enables the faculties and departments to process your application.
